DECISION IV

Pursuant to Art. 5 para. 3 of the Conference Regulations, the Constitutional Court of the Republic of Austria proposes that the following observers and guests be invited to the XVIth Congress of the Conference of European Constitutional Courts.

- 1. Pursuant to Art. 9 para. 2 lit. b of the Statute and Art. 5 para. 1 of the Conference Regulations, the following are to be admitted as observers:

 - The World Conference on Constitutional Justice
 - The Association of Asian Constitutional Courts and equivalent institutions
 - The Association of Constitutional Courts using the French Language (ACCPUF)
 - The Commonwealth courts
 - The Conference of the Constitutional Control Organs of Countries of New Democracy
 - The Conference of Constitutional Jurisdictions of Countries of Portuguese Language
 - The Conference of Constitutional Jurisdictions of Africa
 - The Ibero-American Conference on Constitutional Justice
 - The Southern African Chief Justices Forum
 - The Union of Arab Courts and Constitutional Councils
 - The President of the Constitutional Court of Korea
 - The Chief Justice of the Federal Court of Malaysia

- The Chief Justice of the Constitutional Court of the Republic of Indonesia.
- 2. Pursuant to Art. 9 para. 2 lit. b of the Statute and Art. 5 para. 2 of the Conference Regulations, the following are to be admitted as guests:
 - The President of the Supreme Court
 - The President of the Administrative Court
 - The former Presidents and the Justices of the Constitutional Court of Austria
 - The Austrian Ombudsman Board
 - Distinguished professors of public law and other renowned personalities of academia.

The Circle of Presidents, gathered in Vienna to prepare the XVIth Congress of the Conference of European Constitutional Courts,

unanimously decides

to accept the proposal made by the Constitutional Court of the Republic of Austria (Art. 9 para. 2 lit. b Statute and Art. 5 para. 1 and 2 Conference Regulations).
